**RESOLUTION NO. 274-2021**

**DECLARING ORDINANCE NO. 2018-01 OF THE SANGGUNIANG BAYAN OF BOLINAO, PANGASINAN, ENTITLED "TO ADOPT THE REVISED GENDER AND DEVELOPMENT CODE OF THE MUNICIPALITY OF BOLINAO, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Bolinao, Pangasinan submitted its Ordinance No. 2018-01 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Sections 16 and 17 (a) (iv) of RA 7160; the Gender and Development Code of the Philippines; RA No. 7192 (An Act Promoting the Integration of Woman as Full and Equal Partners of Men in Development and Nation Building and for Other Purposes); and RA No. 9710 (Magna Carta of Women);

**WHEREAS**, subject ordinance shall take effect after compliance with the requirements of posting and publication pursuant to Sections 59 and 511 of RA 7160;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Donabel N. Fontelera and Margielou Orange D. Humilde-Verzosa and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was –


