**RESOLUTION NO. 280-2019**

**APPROVING RESOLUTION NO. 489, S-2016-19 OF THE SANGGUNIANG PANLUNGSOD OF URDANETA, PANGASINAN, ENTITLED "APPROVING THE ANNUAL INVESTMENT PROGRAM (AIP) OF THE CITY OF URDANETA FOR CY 2019"**

**WHEREAS**, the Sangguniang Panlungsod of Urdaneta, Pangasinan submitted its Resolution No. 489, Series of 2016-19 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Urdaneta City, Pangasinan has formulated the city's Annual Investment Program for CY 2019 and endorsed thru CDC Resolution No. 5-2018 dated October 9, 2018 to the Sangguniang Panlungsod for approval. This was subsequently approved by their Sangguniang Panlungsod thru Resolution No. 489, S-2016-19 dated December 13, 2018. This is in consonance to Sections 106, 109 and 114 of RA 7160;
