**DECLARING ORDINANCE NO. 2021-02 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED “AN ORDINANCE IMPOSING FEES FOR DIALYSIS TREATMENT SERVICES AT THE CITY’S HEMODIALYSIS/RENAL CENTER” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG PANLUNGSOD TO ENACT**

**WHEREAS**, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Ordinance No. 2021-02 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 17 (b) (2) (iii) and (viii) (4) and Section 129 of RA 7160;

**WHEREAS**, subject ordinance shall take effect after compliance with the requirements on law of public hearing and publication pursuant to Sections 187 and 188 of RA 7160;


