PROVINCIAL RESOLUTION NO. 285-2019

ADOPTING THE INVENTORY OF CULTURAL PROPERTIES/HISTORICAL LANDMARKS UNDER THE DIRECT CARE AND SUPERVISION OF THE PROVINCIAL GOVERNMENT OF PANGASINAN

WHEREAS, physical or tangible cultural heritage includes buildings and other works of art depicting the history of the Province are worthy of protection and preservation by the Provincial Government of Pangasinan;

WHEREAS, as stated on the DILG Joint Memorandum Circular No. 2018-01, Section 14 (b) and (c) of Republic Act No. 10066, otherwise known as the "National Cultural Heritage Act of 2009", the Provincial Government of Pangasinan must maintain an inventory, evaluation, and documentation of all cultural properties under the direct supervision of the Provincial Government of Pangasinan;

WHEREAS, the Provincial Tourism and Cultural Affairs Office has submitted to the Sangguniang Panlalawigan an updated list of official inventory of cultural properties/historical landmarks under the direct care of the Provincial Government of Pangasinan;

WHEREAS, the list of cultural properties/historical landmarks includes the following:

- 2. Malong Building
- 3. Palaris Building
- 4. Urduja House
- 5. Sison Auditorium
- 6. Bengson-Yuson House
- 7. Princess Urduja Painting (Dumlao)
