**RESOLUTION NO. 288-2019**

**DECLARING MUNICIPAL ORDINANCE NO. 01-2019 OF THE SANGGUNIANG BAYAN OF BURGOS, PANGASINAN, ENTITLED "AN ORDINANCE PROHIBITING THE SNEAKING-IN/SMUGGLING OF CONTRABANDS IN DETENTION CELLS AND JAILS AND IMPOSING PENALTY FOR VIOLATION THEREFORE" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Burgos, Pangasinan submitted its Municipal Ordinance No. 01-2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 16, 447 (a) (1) (ii), (iii), (v) of RA 7160;

**WHEREAS**, however, the Sangguniang Bayan of Burgos, Pangasinan shall consider the observations raised by the Provincial Legal Officer stated in her opinion on the subject ordinance dated March 26, 2019;

**WHEREAS**, subject ordinance shall take effect after the Sangguniang Bayan has complied with the posting and publication requirements set forth in Sections 59 (c) and 511 (a) of RA 7160;
