**RESOLUTION NO. 29-2020**

**APPROVING RESOLUTION NO. 226, S-2019 OF THE SANGGUNIANG BAYAN OF BAUTISTA, PANGASINAN, ENTITLED "APPROVING THE ANNUAL INVESTMENT PROGRAM OF THE MUNICIPALITY OF BAUTISTA, PANGASINAN FUNDED UNDER ANNUAL BUDGET CY 2020 AMOUNTING TO TWENTY MILLION ONE HUNDRED THOUSAND ONE HUNDRED SIXTEEN PESOS AND 60/100 (P20,100,116.60)"**

**WHEREAS**, the Sangguniang Bayan of Bautista, Pangasinan submitted its Resolution No. 226, Series of 2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Bautista, Pangasinan has formulated the municipality's Annual Investment Program for CY 2020 and endorsed thru MDC Resolution No. 05, S-2019 dated September 24, 2019 to the Sangguniang Bayan for approval. This was subsequently approved by their Sangguniang Bayan thru Resolution No. 226, S-2019 dated October 21, 2019. This is in consonance to Sections 106, 109 and 114 of RA 7160;

**WHEREAS**, the Annual Investment Program of the municipality is in accordance with the Budget Operations Manual (BOM) for Local Government Units, 2016 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular (JMC) No. 1, S-2007 dated March 8, 2007 and DBM-CCC-DILG JMC No. 2014-01 dated August 7, 2014, as amended by DBM-CCC-DILG JMC No. 2015-01
