APPROVING AND ADOPTING AS ITS DECISION EN BANC, THE RESOLUTION OF THE COMMITTEE ON GOOD GOVERNMENT AND ACCOUNTABILITY OF PUBLIC OFFICERS, JUSTICE AND HUMAN RIGHTS IN SP ADMINISTRATIVE CASE NO. 01-2020

WHEREAS, the Sangguniang Panlalawigan is in receipt of a Memorandum of Appeal filed on January 17, 2020 by Brgy. Capt. Crisostomo M. Bato against Dominador E. Ragos of Bayambang, Pangasinan for Grave Abuse of Authority, Grave Misconduct and Conduct Unbecoming of a Public Official which was referred to the Committee on Good Government and Accountability of Public Officers, Justice and Human Rights as SP Administrative Case No. 01-2020;

WHEREAS, the Committee on Good Government and Accountability of Public Officers, January 20, 2020 submitted its Resolution embodied in Committee Report No. 12-2021, to wit:

Received by the Committee on 26 January 2021 is a Withdrawal of Appeal by Brgy. Capt. Crisostomo M. Bato, respondent-appellant in the above-entitled case, stating among others that:

- 1. That the parties have amicably settled their differences and have agreed to mutually end their longstanding animosity;*
- 2. That without further discussion on the merits of the case, the Respondent-Appellee signifies his intention to withdraw the instant appeal;*
- 3. That the instant withdrawal does not prejudice public interest; and*
- 4. Neither is the withdrawal contrary to law and jurisprudence.*




