**RESOLUTION NO. 294-2019**

**DECLARING ORDINANCE NO. 10-2018 OF THE SANGGUNIANG BAYAN OF ROSALES, PANGASINAN, ENTITLED “AN ORDINANCE AUTHORIZING THE HONORABLE MAYOR TO SIGN AND ENTER INTO THE LEASE AGREEMENT ON BEHALF OF THE MUNICIPALITY OF ROSALES, PANGASINAN WITH PHILIPPINE PRIMARK PROPERTIES, INC. (THE “LESSEE”) REPRESENTED BY ITS PRESIDENT, BENNISON S. LUA, FOR THE LEASE OF THE ROSALES PUBLIC MARKET PROPERTY WITH AN AREA OF 12,893 SQ. M., MORE OR LESS, LOCATED AT ZONE II, ROSALES, PANGASINAN, FOR THE PURPOSE OF LEASING AND REDEVELOPING SUCH PROPERTY, AND TO ISSUE THE CORRESPONDING NOTICE OF AWARD; RATIFYING AND APPROVING ALL THE TERMS AND CONDITIONS OF THE SAID LEASE AGREEMENT; GRANTING THE LESSEE THE FRANCHISE TO ESTABLISH, CONSTRUCT, OPERATE AND/OR MAINTAIN THE IMPROVED PUBLIC MARKET; AND CONFIRMING THE GRANT OF LOCAL INVESTMENT INCENTIVES TO THE LESSEE” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Rosales, Pangasinan submitted its Ordinance No. 10-2018 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;
