APPROVING MUNICIPAL RESOLUTION NO. 08, S-2021 OF THE SANGGUNIANG BAYAN OF AGUILAR, PANGASINAN, ENTITLED "APPROVING THE REPROGRAMMING IN THE AMOUNT OF THREE MILLION PESOS (P3,000,000.00) EARLIER ALLOCATED FOR THE PURCHASE OF LOT FOR THE SANITARY LANDFILL FROM THE GENERAL FUND 2020 TO CONSTRUCTION OF MULTI-PURPOSE BUILDING WITH GRAVEL FILL WITHIN THE BUILDING AND ITS PERIPHERIES"

**WHEREAS**, the Sangguniang Bayan of Aguilar, Pangasinan submitted its Municipal Resolution No. 08, Series of 2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said municipal resolution and found out that the proposal for reprogramming emanated from the Local Development Council of Aguilar, Pangasinan thru MDC Resolution No. 9, Series of 2020 and endorsed to the Sangguniang Bayan for approval on September 2, 2020;

**WHEREAS**, the funds to be reprogrammed amounting to P3,000,000.00 is earlier allocated for the Purchase of Lot for the Sanitary Landfill Facility funded from the 20% development fund 2020 and embodied in the approved 2020 AIP of the LGU;

WHEREAS, the purpose of reprogramming is to fund the Construction of Multi-Purpose Building to be utilized as an isolation facility and accommodate Covid-19 positive patients as mentioned in the subject resolution. This new development project
