**APPROVING RESOLUTION NO. 19(A)-072 OF THE SANGGUNANG PANLUNGSOD OF SAN CARLOS, PANGASINAN, ENTITLED “REALIGNING THE AMOUNT OF NINE MILLION SEVEN HUNDRED FOURTEEN THOUSAND NINE HUNDRED SIXTY-TWO PESOS (P9,714,962.00) FROM THE BUDGET OF GAD UNEXPENDED BALANCE AVAILABLE TO PROVIDE FUNDS FOR SIX NEWLY SUPPLEMENTED PROJECTS UNDER GAD RELATED ACTIVITIES”**

**WHEREAS**, the Sangguniang Panlungsod of San Carlos, Pangasinan submitted its Resolution No. 19(A)-072 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the City Development Council – Executive Committee of San Carlos City, Pangasinan has proposed to the Sangguniang Panlungsod the realignment of the sum of P9,714,962.00 from GAD Budget to finance the implementation of new GAD-related projects. This was endorsed thru CDC Resolution No. 12-19 dated November 20, 2019 to the Sangguniang Panlungsod for approval. The Sangguniang Panlungsod approved said endorsement through Sangguniang Panlungsod Resolution No. 19(A)-072 dated November 25, 2019;


