APPROVING RESOLUTION NO. 8, S-2019 OF THE SANGGUNIANG BAYAN OF BUGALLON, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 1 FOR FY 2019 OF THE MUNICIPALITY OF BUGALLON, PANGASINAN AMOUNTING TO EIGHT MILLION TWO HUNDRED NINETY TWO THOUSAND FIVE HUNDRED FORTY SEVEN PESOS (P8,292,547.00)"

**WHEREAS**, the Sangguniang Bayan of Bugallon, Pangasinan submitted its Resolution No. 8, Series of 2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109 and 114 of RA 7160. The Local Development Council of Bugallon, Pangasinan had identified items in their Supplemental Investment Program No. 1 for CY 2019. This was endorsed to the Sangguniang Bayan for approval on January 31, 2019 by the MDC thru Resolution No. 01, S-2019 and was favorably acted upon by the Sangguniang Bayan on February 19, 2019 thru SB Resolution No. 8, S-2019;

WHEREAS, the Supplemental Investment Program No. 1 of the municipality covers the fund augmentation for Personal Services and Maintenance and Other Operating Expenses of various municipal offices and implementation of gender related programs, disaster risk reduction activities and development projects of the municipality;

WHEREAS, the proposed Supplemental Investment Program has an investment requirement of P8,292,547.00. Funding support for the implementation of the same is embodied in their proposed Supplemental Budget No. 1, CY 2019, which was approved and enacted by their Sangguniang Bayan on February 19, 2019 thru Appropriation Ordinance No. 2019-01;
