**APPROVING RESOLUTION NO. 95-2020 OF THE SANGGUNANG BAYAN OF SAN JACINTO, PANGASINAN, ENTITLED “APPROVING THE ANNUAL INVESTMENT PROGRAM FOR CY 2021 OF THE MUNICIPALITY OF SAN JACINTO, PANGASINAN”**

**WHEREAS**, the Sangguniang Bayan of San Jacinto, Pangasinan submitted its Resolution No. 95-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109 and 114 of RA 7160. The Municipal Development Council of San Jacinto, Pangasinan had identified and prioritized programs and projects in their Annual Investment Program for Calendar Year 2021. This was endorsed by the Council to the Sangguniang Bayan through MDC Resolution No. 2020-04 dated October 2, 2020;

**WHEREAS**, the Annual Investment Program of the municipality is in accordance with the Budget Operations Manual (BOM) for Local Government Units, 2016 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular (JMC) No. 1, S-2007 dated March 8, 2007 and DBM-CCC-DILG JMC No. 2014-01 dated August 7, 2014, as amended by DBM-CCC-DILG JMC No. 2015-01 dated July 23, 2015 as to format and content. The AIP of San Jacinto, Pangasinan was prepared using the prescribed AIP Summary Form, and covers: a) all the regular budgetary requirements for the operations of the different city offices broken down into: Personal Services (PS), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay, b) the priority

development programs/projects of the LGU including those to be funded by the 20% development fund, c) Disaster Risk Reduction (DRR) programs, projects and activities, and d) activities in pursuance of the objectives of GAD of the LGU. Also attached to the AIP are the following: a) Local Climate Change Action Plan, CY 2021, b) Peace and Order Plan, CY 2021, c) List of Programs/Projects/Activities for the Local Council for the Protection of Children, d) List of PPAs for Senior Citizens and Persons with Disabilities, and e) List of PPAs to combat Acquired Immune Deficiency Syndrome (AIDS);

**WHEREAS**, the AIP contains PPAs which will be funded by the LGU in the amount of P148,636,974.08, as embodied in their 2021 Annual Budget passed and approved by their Sangguniang Bayan through Appropriation Ordinance No. 04, S-2020 dated December 18, 2020. It also includes proposed programs and projects to be funded by the DILG and other external sources;

**WHEREAS**, said AIP is in accordance with Section 287 of RA 7160. Twenty percent (20%) of the LGU's IRA (P127,127,288.00), amounting to P25,425,457.60 is allocated for development projects. These development programs/projects conform to the Joint DBM-DOF-DILG Memorandum Circular No. 2017-1, dated February 22, 2017 (*Updated Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment (IRA) for Development Projects*);

**WHEREAS**, the programs and projects included in the Municipal Disaster Risk Reduction and Management Investment Plan, amounting to P7,435,114.40, were based on Section 21 of RA 10121 and Memorandum Circular No. 2013-1 of the NDRRMC, DBM and DILG dated March 25, 2013 (*Joint Allocation and Utilization of Local Disaster Risk Reduction and Management Fund*). Further, the LDRRM Plan of the LGU has been submitted to the Office of Civil Defense-RO1 for their review and evaluation;

**WHEREAS**, the Gender and Development Plan and Budget for CY 2021 of the LGU has been reviewed and approved by the Department of Interior and Local Government (DILG) Provincial Office, and were found to be fully compliant in form and in contents with the provisions of the DBM, PCW, DILG & NEDA Joint Memorandum Circular No. 2016-01: Amendments to JMC 2013-01 re: Guidelines on the Localization of Magna Carta of Women;

**WHEREAS**, the LGU had also identified programs, projects and activities responsive to Climate Change and tagged its corresponding expenditures in their AIP. This is in pursuance to DBM-CCC-DILG Joint Memorandum Circular No. 2015-01 dated July 23, 2015;

**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all existing laws, rules and regulations shall be the responsibility of the Municipal Government of San Jacinto;
