DECLARING ORDINANCE NO. 18, S-2020 OF THE SANGGUNIANG BAYAN OF ASINGAN, PANGASINAN, ENTITLED "AN ORDINANCE CHARGING SOCIALIZED FEES IN THE AMOUNT OF ONE THOUSAND PESOS (P1,000.00) FOR SIMULATION OF BIRTH RECTIFICATION" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

**WHEREAS**, the Sangguniang Bayan of Asingan, Pangasinan submitted its Ordinance No. 18, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Sections 129, 132 and 447 (a) (5) of RA 7160; and Section 13 of RA No. 11222 entitled "An Act Allowing the Rectification of Simulated Birth Records and Prescribing Administrative Adoption Proceedings for the Purpose";

**WHEREAS**, subject ordinance shall take effect after all the requirements of law on public hearing, posting and publication pursuant to Sections 187, 188, 59 and 511 of RA 7160 are complied with;
