**PROVINCIAL RESOLUTION NO. 306-2019**

**AUTHORIZING THE PROVINCIAL GOVERNMENT OF PANGASINAN THROUGH THE HONORABLE GOVERNOR, AMADO I. ESPINO, III, TO PURCHASE TWO (2) UNITS TRAINING TRUCKS FOR USE IN THE IMPLEMENTATION OF MOBILE SKILLS TRAINING PROJECT (MSTP) IN PANGASINAN**

**WHEREAS**, one of the primordial concerns of the Provincial Government of Pangasinan is to reach out to the grassroots by designing programs that will greatly help in the skills and workforce development of Pangasinenses, especially the youth, in various trades and crafts;

**WHEREAS**, the Provincial Government of Pangasinan, through the Provincial Employment Services Office (PESO), intends to expand the implementation of the Mobile Skills Training Project (MSTP) in the Province of Pangasinan to provide continuous education and quality training that will enhance the productivity and employability of Pangasinan's labor force;

**WHEREAS**, in order to realize the purpose of the said program, the Province of Pangasinan needs to purchase additional two (2) units Training Trucks installed with appropriate training technologies and educational resources;

**WHEREAS**, the project is in line with the Manpower and Entrepreneurship Development Program of the Province to prepare the trainees for potential employment that are locally needed and for global competitiveness;

**WHEREAS**, the procurement of the said vehicle shall comply with DILG Memorandum Circular No. 2014-155 dated December 17, 2014 which provides the "Guidelines on Motor Vehicles Acquisition by the Local Government Units";
