**APPROVING MUNICIPAL RESOLUTION NO. 2021-32 OF THE SANGGUNIANG BAYAN OF MANGALDAN, PANGASINAN, ENTITLED “APPROVING AND ADOPTING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 1, CY 2021 OF THE MUNICIPALITY OF MANGALDAN”**

**WHEREAS**, the Sangguniang Bayan of Mangaldan, Pangasinan submitted its Municipal Resolution No. 2021-32 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said municipal resolution and found out that the Municipal Development Council – Executive Committee of Mangaldan, Pangasinan prepared their Supplemental Annual Investment Program (SAIP) No. 1 for CY 2021. This was endorsed by the Council, through MDC Resolution No. 1, Series of 2021 dated February 2, 2021 to the Sangguniang Bayan for approval;

**WHEREAS**, the Sangguniang Bayan approved said endorsement through Sangguniang Bayan Resolution No. 2021-32 dated February 19, 2021;

**WHEREAS**, said Supplemental AIP, has a total investment requirement of P66,890,637.88. P3,428,739.88 will be for the granting of salary increase through the implementation of the Second Tranche of its modified Salary Schedule of Local Government Personnel. This is supported by the LGUs Supplemental Budget No. 1, CY 2021, and approved by their Sangguniang Bayan through Appropriation Ordinance No. 2021-03 dated February 19, 2021;

**WHEREAS**, the Supplemental AIP also includes programs/projects prepared to be funded by (a) *municipal shares from the collections of Burley and Native Tobacco* (P17,861,898.00); (b) *LGSF-other Financial Assistance to LGUs* (P45,500,000.00); and (c) *LGSF-Disaster Rehab and Reconstruction Assistance Program* (P100,000.00);


**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all existing laws, rules and regulations shall be the responsibility of the Municipal Government of Mangaldan;
