RESOLUTION NO. 308-2019

REMANDING ORDINANCE NO. 2018-12 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED "AN ORDINANCE UPDATING CITY ORDINANCE NO. 2005-03, OTHERWISE KNOWN AS THE CODE ON CHILDREN IN THE CITY OF ALAMINOS, PANGASINAN"

WHEREAS, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Ordinance No. 2018-12 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same shall be remanded to the Sangguniang Panlungsod of Alaminos, Pangasinan to enable the Sanggunian of origin consider the observations of the Provincial Legal Officer stated in her opinion dated April 1, 2019, as attached in this Resolution;




