**APPROVING RESOLUTION NO. 52-2018 OF THE SANGGUNIANG BAYAN OF URBIZTONDO, PANGASINAN, ENTITLED "APPROVING THE REVISED ANNUAL INVESTMENT PROGRAM FOR CALENDAR YEAR 2018 OF THE MUNICIPALITY OF URBIZTONDO, PANGASINAN"**

**WHEREAS**, the Sangguniang Bayan of Urbiztondo, Pangasinan submitted its Resolution No. 52-2018 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Annual Investment Program of the Municipality of Urbiztondo for CY 2018 with a total investment requirement of P129,435,907.00 and its supporting Annual Budget were approved by the Sangguniang Panlalawigan on December 11, 2017;

**WHEREAS**, the Municipal Development Council of Urbiztondo has prepared a Revised AIP with an estimated investment requirement of P133,727,321.30 and endorsed the same to the Sangguniang Bayan for approval on November 26, 2018 thru MDC Resolution No. 04, S-2018. This was favorably acted upon by the Sangguniang Bayan on November 28, 2018 thru SB Resolution No. 52-2018. This is in consonance to Sections 106, 109 and 114 of the LGC of 1991;


