UTANES TO ENROLL IN THE ELECTRONIC PAYMENT SYSTEM (EPS) OF THE LAND BANK OF THE PHILIPPINES IN PURSUANT TO PHILHEALTH CIRCULAR NO. 2020-0008, AND THE AUTHORIZED USERS/ENROLLEES ARE AS FOLLOWS: MARILOU E. UTANES, PROVINCIAL TREASURER AS AUTHORIZER, CRISTY C. UBANDO, SUPERVISING ADMINISTRATIVE OFFICER AS MAKER, AND JENNIFER A. CONDE, ADMINISTRATIVE AIDE VI AS MAKER

WHEREAS, pursuant to Philhealth Circular No. 2020-0008, employers are required to enroll their Electronic Premium Remittance System (EPRS) account at any Accredited Collecting Agent (Land Bank of the Philippines) with payment gateway/facility interlinked with EPRS to be able to remit premium online;

WHEREAS, Provincial Government of Pangasinan recognizes the necessity of enrolling the Provincial Current Account No. 2422-1000-51 with the online payment facility of the EPRS introduced by Philhealth as it provides faster acknowledgement of premium payments thereby providing ease, convenience and security to employers just like our local unit;
