DECLARING ORDINANCE NO. 2021-03 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED "AN ORDINANCE AMENDING SECTION 2 OF THE CITY ORDINANCE NO. 2020-19 GRANTING CONCESSIONS TO THE RENTALS OF COMMERCIAL STALLS OWNED BY THE LOCAL GOVERNMENT UNIT OF THE CITY OF ALAMINOS, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG PANLUNGSOD TO ENACT

WHEREAS, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Ordinance No. 2021-03 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Sections 129, 132 and 192 of RA 7160 and Section 4 (2) of RA No. 11469, otherwise known as "Bayanihan to Heal as One Act";

WHEREAS, subject ordinance shall take effect after compliance with the requirements of posting and publication pursuant to Sections 59 (a) and 188 of RA 7160;
