PROVINCIAL RESOLUTION NO. 312-2020

URGING LOCAL GOVERNMENT UNITS CONCERNED IN THE PROVINCE OF PANGASINAN TO APPOINT THEIR ENVIRONMENT AND NATURAL RESOURCES OFFICER IN THEIR RESPECTIVE LOCALITIES

WHEREAS, pursuant to Section 484 of the Local Government Code of 1991, the Municipal/City Mayor may appoint an Environment and Natural Resources Officer;

WHEREAS, the Environment and Natural Resources Officer shall formulate measures for consideration of the Sanggunian and provide technical assistance and support to the Mayor to ensure sustainable use, development, management, protection and preservation of the environment and natural resources of the municipalities/cities;

WHEREAS, the Environment and Natural Resources Officer shall also assist the Mayor to efficiently and effectively ensure the delivery of basic services and provide adequate facilities relative to environmental functions and responsibilities as provided for under Section 17 of the said Code;

WHEREAS, the Environment and Natural Resources Officer shall play an essential role during and in the aftermath of man-made and natural disasters and calamities as he shall be in the frontline of the delivery of services particularly in the renewal and rehabilitation of the environment and natural resources;

WHEREAS, the Sangguniang Panlalawigan recognizes the importance of having an Environment and Natural Resources Officer in the municipalities and cities of the Province, as local government units have wider and more definite tasks in maintaining sustainable environmental and natural resources programs and projects;


