RESOLUTION NO. 317-2019

DECLARING MUNICIPAL ORDINANCE NO. 2-2018 OF THE SANGGUNIANG BAYAN OF ANDA, PANGASINAN, ENTITLED "AN ORDINANCE REPEALING MUNICIPAL ORDINANCE NO. 07, SERIES OF 2005 (AN ORDINANCE ADOPTING THE CHILDREN'S WELFARE CODE OF THE MUNICIPALITY OF ANDA, PANGASINAN AND FOR OTHER PURPOSES), SUBJECT TO ALL LEGAL AND EXISTING RULES AND REGULATIONS" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Anda, Pangasinan submitted its Municipal Ordinance No. 2-2018 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section 17 (b) (2) (iii) and (iv), and Section 447 (5) (xiv) of RA 7160; Presidential Decree No. 603 or The Child and Youth Welfare Code; the United Nations Convention on the Rights of the Child; RA 7610 of 1992 (The Special Protection of Children Against Child Abuse, Exploitation and Discrimination Act);

WHEREAS, however, the Sangguniang Bayan shall consider the observations of the Provincial Legal Officer stated in her opinion dated May 16, 2019 (which were not yet addressed by the Sanggunian), as attached in this Resolution;
