RESOLUTION NO. 318-2019

DECLARING MUNICIPAL ORDINANCE NO. 1-2019 OF THE SANGGUNIANG BAYAN OF ANDA, PANGASINAN, ENTITLED "AN ORDINANCE OTHERWISE KNOWN AS THE COMPREHENSIVE TRAFFIC CODE OF ANDA, PANGASINAN AND PRESCRIBING PENALTIES IN VIOLATION THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Anda, Pangasinan submitted its Municipal Ordinance No. 1-2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section 447 (a) (1) (iii), (5) (v) and (vi) of RA 7160;

WHEREAS, however, the Sangguniang Bayan shall consider the observations of the Provincial Legal Officer stated in her opinion dated March 28, 2019, as attached in this Resolution;

WHEREAS, subject ordinance shall take effect after all of legal requirements set forth in RA 7160 are complied with;
