DECLARING MUNICIPAL ORDINANCE NO. 09-2021 OF THE SANGGUNIANG BAYAN OF MANAOAG, PANGASINAN, ENTITLED "AN ORDINANCE RECLASSIFYING THE 49,467 SQ.M. LOT OWNED BY FOREST LAKE DEVELOPMENT INC., FROM AGRICULTURAL TO SPECIAL USE LOT PURPOSES LOCATED **BARANGAY** BARITAO. AT MANAOAG. PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Manaoag, Pangasinan submitted its Municipal Ordinance No. 09-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer, Provincial Planning and Development Coordinator, Provincial Agrarian Reform Program Officer II and Department of Human Settlements and Urban Development Regional Director have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 20 and 447 (a) (2) (viii) of R.A. No. 7160;

WHEREAS, the Municipality of Manaoag has an existing Zoning Ordinance implementing its Comprehensive Land Use Plan CY 1996-2005. Said CLUP and Zoning Ordinance, however, needs updating;

WHEREAS, Clearance for Reclassification (Certifications) from the Department of Agriculture and Department of Agrarian Reform must be secured and submitted to the Sangguniang Panlalawigan before the subject ordinance will be implemented;

WHEREFORE, in view of the foregoing, on motion of SP Members Jeremy Agerico B. Rosario and Liberato Z. Villegas and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 09, S-2021 of the Sangguniang Bayan of Manaoag, Pangasinan, entitled "An Ordinance reclassifying the 49,467 sq. m. lot owned by Forest Lake Development Inc., from agricultural to special use lot purposes located at Barangay Baritao, Manaoag, Pangasinan" as within the conferred powers of the Sangguniang Bayan to enact;
