RESOLUTION NO. 321-2019

DECLARING MUNICIPAL ORDINANCE NO. 05, S-2018 OF THE SANGGUNIANG BAYAN OF BANI, PANGASINAN, "AN **ORDINANCE** ENTITLED **PROHIBITING. REGULATING AND PRESCRIBING CERTAIN USES OF** PLASTICS FOR GOODS AND COMMODITIES THAT END **UP AS RESIDUAL WASTES AND PROMOTING THE USE** OF ECO-BAGS AND OTHER ENVIRONMENTAL FRIENDLY PRACTICES AS AN ALTERNATIVE AND **PROVIDING PENALTIES FOR VIOLATIONS THEREOF"** AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Bani, Pangasinan submitted its Municipal Ordinance No. 05, Series of 2018 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 16 and 447 (a) (iii) (5) of RA 7160;

WHEREAS, however, the Sangguniang Bayan shall consider the observations of the Provincial Legal Officer stated in her opinion dated March 18, 2019, as attached in this Resolution;

> WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Antonio F. Sison and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Arth Bryan C. Celeste, duly seconded, it was –

> **RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 05, S-2018 of the Sangguniang Bayan of **Bani**, Pangasinan, entitled "An Ordinance prohibiting, regulating and prescribing certain uses of plastics for goods and commodities that end up as residual wastes and promoting the use of eco-bags and other environmental friendly practices as an alternative and providing penalties for violations thereof" as within the conferred powers of the Sangguniang Bayan to enact;
