PROVINCIAL RESOLUTION NO. 323-2021

URGING ALL DEPARTMENT OF EDUCATION SCHOOLS DIVISIONS SUPERINTENDENTS IN THE PROVINCE OF PANGASINAN TO ADDRESS THE ISSUE ON NON-CONFORMITY IN THE DEPLOYMENT OF SCHOOL HEADS IN COMPLIANCE WITH STATION SPECIFIC POLICY OF THE CIVIL SERVICE COMMISSION

WHEREAS, Section 13, Rule IV of Civil Service Commission Resolution No. 1701009 (2017 Omnibus Rules on Appointments and Other Human Resource Actions), dated June 16, 2017, provides that an appointment is station-specific if the employee's appointment paper specifically indicates on its face the particular office or station the position is located. Moreover, the station should already be specified in the position title, even if the place of assignment is not indicated on the face of the appointment;

WHEREAS, on the part of DepEd order pertaining to the transfer of station, upon a teacher's appointment, assignment to a station, and acceptance of the position, he or she shall not be transferred to another school until after rendering at least three (3) years of service on that school;

WHEREAS, there are instances, however, in the Province of Pangasinan when a school head is transferred to another school but still carries with him/her the position item which belongs to his/her former school;

WHEREAS, it is imperative to effect transfers of school heads from one station to another in order for the Department of Education (DepEd) to ensure the equity of school head deployment, however, there is the issue of whether the school head is allowed to carry a position item which belongs to another station or that a position item will be transferred to another locality;

WHEREAS, the issue on the non-conformity in the deployment of schools heads has to be resolved by the DepEd Schools Division Superintendents in the Province of Pangasinan;

NOW, THEREFORE, on motion of SP Member Jeremy Agerico B. Rosario, duly seconded, it was –


