APPROVING RESOLUTION NO. 40, S-2019 OF THE SANGGUNIANG BAYAN OF INFANTA, PANGASINAN, ENTITLED "APPROVING THE FIRST SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) FOR FY 2019 OF THE MUNICIPALITY OF INFANTA, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Infanta, Pangasinan submitted its Resolution No. 40, Series of 2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109 and 114 of RA 7160. The Municipal Development Council of Infanta, Pangasinan had identified items in their First Supplemental Investment Program for CY 2019 with a total investment requirement of P3,940,286.76. This was endorsed to the Sangguniang Bayan for approval on April 8, 2019 thru MDC Resolution No. 1, S-2019 and was favorably acted upon by the Sangguniang Bayan on April 15, 2019 thru SB Resolution No. 40, S-2019;

WHEREAS, the First Supplemental Investment Program of the municipality covers fund augmentation for Maintenance and Other Operating Expenses and Capital Outlay of Executive Services and for the implementation of programs and projects for the operation of Infanta Waterworks System, Market and Slaughterhouse;
