RESOLUTION NO. 327-2019

DECLARING MUNICIPAL ORDINANCE NO. 8, S-2018 OF THE SANGGUNIANG **BAYAN OF** AGUILAR, PANGASINAN. **ENTITLED** "AN **ORDINANCE** OTHERWISE KNOWN AS THE MUNICIPAL CODE PURSUING A PUBLIC-PRIVATE PARTNERSHIP (PPP) APPROACH TOWARDS DEVELOPMENT PROVIDING FOR THE PROCEDURE FOR SELECTING THE PRIVATE SECTOR PROPONENT, ADOPTING A CONTRACT **MANAGEMENT** FRAMEWORK **PROVIDING** AND APPROPRIATIONS AND FOR OTHER PURPOSES" AS WITHIN THE **CONFERRED POWERS** SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Aguilar, Pangasinan submitted its Municipal Ordinance No. 8, Series of 2018 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 35, 106, 447 (a) (2) of RA 7160; Article 2, Section 20 of the Philippine Constitution; and RA 7718, An Act Amending Certain Sections of RA 6957 (An Act Authorizing the Financing the Construction, Operation and Maintenance of Infrastructure Projects by the Private Sector, and For Other Purposes), otherwise known as The Build, Operate and Transfer Law;
