PROVINCIAL RESOLUTION NO. 327-2022

AUTHORIZING THE HONORABLE GOVERNOR, AMADO I. ESPINO III, TO PURCHASE MOTOR VEHICLES FOR USE BY THE PROVINCIAL GOVERNMENT OF PANGASINAN

WHEREAS, it is the main objective of the Provincial Government of Pangasinan to generate and maximize the use of its resources for the development plans, program objectives and priority projects of the Province;

WHEREAS, the Provincial Government of Pangasinan would like to ensure the delivery of basic services through the provision of adequate means of transportation not only for the urban areas but also to the countryside;

WHEREAS, the Provincial Government of Pangasinan is inclined to purchase motor vehicles which shall be used by the Provincial Agriculture Office for its Mobile Agro-Fishery Techno Clinic and the Provincial Health Office for its Immunization Committee;

WHEREAS, there is a need therefore to authorize the Provincial Governor to cause the purchase of six (6) units Multi-Purpose Vehicle for use by the Provincial Agriculture Office to be funded from the Development Bank of the Philippines loan proceeds with a total cost of P8,400,000.00 with the following specifications:

WHEREAS, likewise, one (1) unit Passenger Van for the Provincial Health Office is to be funded also from the Development Bank of the Philippines loan proceeds with a total cost of P2,500,000.00 with the following specifications:
