**DECLARING MUNICIPAL ORDINANCE NO. 11, S-2019 OF** THE SANGGUNIANG **BAYAN OF** AGUILAR, PANGASINAN, "AN **ENTITLED ORDINANCE ESTABLISHING** THE AGUILAR RHU BIRTHING FACILITY OF AGUILAR, PANGASINAN AND DEFINING ITS FUNCTIONS, OPERATIONS AND ADMINISTRATION" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

**WHEREAS**, the Sangguniang Bayan of Aguilar, Pangasinan submitted its Municipal Ordinance No. 11, Series of 2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section 17 (b) (2) (iii) (viii) and Sections 129 and 132 of RA 7160;
