RESOLUTION NO. 328-2020

DECLARING ORDINANCE NO. 2, S-2020 OF THE SANGGUNIANG BAYAN OF ASINGAN, PANGASINAN, ENTITLED "AN ORDINANCE REGULATING THE OWNERSHIP, CARE AND UPKEEPING OF DOGS IN THE MUNICIPALITY OF ASINGAN, PANGASINAN AND FOR OTHER PURPOSES" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Asingan, Pangasinan submitted its Ordinance No. 2, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 16 and Section 447 (a) (1) (iii), (4) (viii) of RA 7160; RA No. 9482 (Anti-Rabies Act of 2007);

WHEREAS, however, the Sangguniang Bayan shall observe and comply with the four observations of the Provincial Legal Officer stated in her opinion dated February 7, 2020;

WHEREAS, subject ordinance shall take effect after the Sanggjuniang Bayan has complied with the requirements of posting and publication pursuant to Sections 59 and 511 of RA 7160;
