APPROVING RESOLUTION NO. 2020-148 OF THE SANGGUNIANG BAYAN OF BALUNGAO, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (SAIP) NO. 1 FOR THE CALENDAR YEAR 2020 OF THE MUNICIPALITY OF BALUNGAO, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Balungao, Pangasinan submitted its Resolution No. 2020-148 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Balungao, Pangasinan has adopted and endorsed municipality's Supplemental Annual Investment Program No. 1 thru MDC Resolution No. 2020-01 dated January 6, 2020 to the Sangguniang Bayan for approval. This was approved by their Sangguniang Bayan on January 15, 2020 thru Resolution No. 2020-148. This is in pursuance to Sections 106, 109 and 114 of RA 7160;

WHEREAS, the Supplemental Annual Investment Program No. 1 with an investment requirement amounting to P2,114,529.00 covers the fund augmentation for the Personal Services requirement of the various offices of the municipal government of Balungao;

WHEREAS, on January 15, 2020, the Sangguniang Bayan enacted Supplemental Budget No. 1 through Appropriation Ordinance No. 2020-01 to support the implementation of the Supplemental Annual Investment Program No. 1;


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;
