RESOLUTION NO. 329-2021

APPROVING CITY RESOLUTION NO. 20-096 OF THE SANGGUNIANG PANLUNGSOD OF SAN CARLOS CITY, PANGASINAN, ENTITLED "APPROVING AND ADOPTING THE ANNUAL INVESTMENT PROGRAM FOR CALENDAR YEAR 2021 OF THE CITY GOVERNMENT OF SAN CARLOS (PANGASINAN)"

WHEREAS, the Sangguniang Panlungsod of San Carlos, Pangasinan submitted its City Resolution No. 20-096 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109 and 114 of RA 7160. The City Development Council of San Carlos, Pangasinan had identified and prioritized programs and projects in their Annual Investment Program for Calendar Year 2021. This was endorsed by the Council to the Sangguniang Panlungsod through CDC Resolution No. 16-20 (Series of 2020) dated October 6, 2020;

WHEREAS, the Annual Investment Program of the city is in accordance with the Budget Operations Manual (BOM) for Local Government Units, 2016 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular (JMC) No. 1, S-2007 dated March 8, 2007 and DBM-CCC-DILG JMC No. 2014-01 dated August 7, 2014, as amended by DBM-CCC-DILG JMC No. 2015-01 dated July 23, 2015 as to format and content. The AIP of San Carlos City, Pangasinan was prepared using the prescribed AIP Summary Form, and covers: a) all the regular budgetary requirements for the operations of the different offices broken down into: Personal Services (PS), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay, b) the priority

development programs/projects of the LGU including those to be funded by the 20% development fund, c) Disaster Risk Reduction programs, projects and activities, and d) activities in pursuance of the objectives of GAD of the LGU. Also attached to the AIP are the following: a) Local Climate Change Action Plan, b) Localized Anti-Criminality Action Plan, c) List of programs, projects and activities for the Local Council for the Protection of Children, d) List of programs, projects and activities for Senior Citizens and Persons with Disabilities, e) List of programs, projects and activities for AIDS, f) List of programs, projects and activities for AIDS, f) List of programs, projects and activities for Culture and Arts, g) Nutrition Action Plan, and h) Annual Procurement Plan;

WHEREAS, the AIP contains Programs, Projects and Activities which will be funded by the LGU in the amount of P942,844,638.79, as embodied in their 2021 Annual Budget passed and approved and enacted by their Sangguniang Panlungsod through Appropriation Ordinance No. 20-16 dated December 7, 2020;

WHEREAS, the Annual Investment Program also includes proposed programs and projects to be funded by National Government Agencies;

WHEREAS, this AIP is in accordance with Section 287 of RA 7160. Twenty percent (20%) of the LGU's IRA (P813,147,257.00), amounting to P162,629,451.40, is allocated for development projects;

WHEREAS, the development projects proposed to be funded by the 20% development fund were based on the Joint DBM-DILG Memorandum Circular No. 2017-1, dated February 22, 2017 entitled (Updated Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment (IRA) for Development Projects);

WHEREAS, the programs and projects included in the 5% Local Disaster Risk Reduction and Management Investment Plan/Program, amounting to P47,159,062.81, were already reviewed by Office of the Civil Defense – Regional Office 1 as part of their Six-Year LDRRM Plan (2019-2024) and the LGU shall consider to adopt the necessary amendments to the Plan and submit the revised Plan to the OCD-RO1;

WHEREAS, the LGU had also identified programs, projects and activities responsive to Climate Change and tagged its corresponding expenditures in their AIP. This is in pursuance to DBM-CCC-DILG Joint Memorandum Circular No. 2015-01 dated July 23, 2015;

WHEREAS, the Gender and Development Plan and Budget for CY 2021 of the LGU has been reviewed and approved by the Department of Interior and Local Government (DILG) Provincial Office, and found to be compliant in form and content with the provisions of the Joint Memorandum Circular (DBM, PCW, DILG & NEDA) No. 2016-01: Amendments to JMC 2013-01 re: Guidelines on the Localization of Magna Carta of Women;
