WHEREAS, President Rodrigo Roa has promoted recently nine Philippine Coast Guard Captains to the next higher rank of Commodore based on the recommendation of Department of Transportation Secretary Arthur P. Tugade;

WHEREAS, one of those promoted is a native son of Pangasinan, CG Commodore Eduardo P. De Luna, current Deputy Commander of Coast Guard Fleet;

WHEREAS, CG Commodore De Luna, upon graduation from the University of Pangasinan with the degree of Bachelor of Science in Civil Engineering, had immediately entered the uniformed service by joining the Armed Forces of the Philippines's Officer Candidate School in 1993 and later on joined the Philippine Navy;

WHEREAS, CG Commodore De Luna, after more than three years of shipboard duty, had been assigned at the Headquarters of the Philippine Coast Guard (PCG) and from then on had held several positions until he had been the very first ever designated Promotions Board Secretariat when the PCG became independent from the Philippine Navy and was transferred to the Department of Transportation and Communications in 1998;

WHEREAS, CG Commodore De Luna had also joined the Coast Guard Aviation Group (CGAG) in 1999 to 2006 and after more than seven (7) years, he had earned his private pilot license for fixed wing aircraft and Commercial Helicopter Pilot license for rotary wing;
