#### **RESOLUTION NO. 33-2019**

**DECLARING MUNICIPAL ORDINANCE NO. 10, S-2018 OF** SANGGUNIANG BAYAN **OF** URBIZTONDO. "AN PANGASINAN. **ENTITLED ORDINANCE** PROVIDING FOR THE SPEED LIMITS FOR ALL KINDS OF MOTOR VEHICLES WITHIN THE TERRITORIAL JURISDICTION THE MUNICIPALITY **OF** URBIZTONDO, PANGASINAN, PROVIDING PENALTIES FOR THE VIOLATION THEREOF, COLLECTION OF ROAD CRASH DATA AND APPROPRIATING FUNDS FOR THIS PURPOSE" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

**WHEREAS**, the Sangguniang Bayan of Urbiztondo, Pangasinan submitted its Municipal Ordinance No. 10, Series of 2018 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section 447 (a) (5) (v) and (vi) of RA 7160;

**WHEREAS**, subject ordinance shall take effect after the requirements set forth in Sections 59 and 511 (a) of RA 7160 has been complied with by the Sangguniang Bayan;
