RESOLUTION NO. 330-2020

DECLARING THE SUPPLEMENTAL BUDGET NO. 1 FOR CALENDAR YEAR 2020 OF BALUNGAO, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P2,114,529.00 OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to R.A. No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Balungao, Pangasinan submitted its Supplemental Budget No. 1 for Calendar Year 2020 involving total appropriations of **P2,114,529.00** which was approved on January 15, 2020 through Appropriation Ordinance No. 2020-01;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget with the finding that the creation of positions shall be in accordance with the provisions of Civil Service Commission Memorandum Circular No. 19, S-1992 dated May 7, 1992 re: Guidelines and Standards in the Establishment of Organizational Structures and Staffing Patterns in Local Government Units, and that priority shall be given to the creation of mandatory positions;

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;
