**RESOLUTION NO. 331-2020**

**DECLARING MUNICIPAL ORDINANCE NO. 86, S-2020 OF THE SANGGUNIANG BAYAN OF SAN NICOLAS, PANGASINAN, ENTITLED “AN ORDINANCE PREVENTING ACTS OF BULLYING COMMITTED AMONG STUDENTS IN SAN NICOLAS, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of San Nicolas, Pangasinan submitted its Municipal Ordinance No. 86, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section 17 and Section 447 (1) (iii) of RA 7160; RA No. 10627 entitled “An Act Requiring Elementary and Secondary Schools to Adopt Policies to Prevent and Address the Acts of Bullying in their Institution”; Section 3 (2) Article XV of the Philippine Constitution; Presidential Decree No. 603 (Child and Youth Welfare Code); and RA No. 7610 (Special Protection of Children Against Abuse, Exploitation and Dissemination Act);

**WHEREAS**, however, the Sangguniang Bayan shall observe and comply with the five observations of the Provincial Legal Officer stated in her opinion dated February 19, 2020;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez, Jr. and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jose G. Peralta, Jr., duly seconded, it was –
