DECLARING MUNICIPAL ORDINANCE NO. 3, S-2022 OF THE SANGGUNIANG BAYAN OF BINMALEY, PANGASINAN, ENTITLED "AN ORDINANCE CREATING THREE (3) PLANTILLA POSITIONS OF ADMINISTRATIVE AIDE III (UTILITY WORKER II), SG 3, UNDER THE OFFICE OF THE ECONOMIC ENTERPRISE AND SLAUGHTERHOUSE AND OFFICE OF THE MAYOR OF THE EXECUTIVE DEPARTMENT OF THE MUNICIPALITY OF BINMALEY, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT
