RESOLUTION NO. 334-2019

DECLARING MUNICIPAL ORDINANCE NO. 2019-01 OF THE SANGGUNIANG BAYAN OF BUGALLON, PANGASINAN, ENTITLED "AN ORDINANCE ABOLISHING FOUR VACANT POSITIONS AND CREATING FIVE NEW POSITIONS IN THE MUNICIPALITY OF BUGALLON, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Bugallon, Pangasinan submitted its Municipal Ordinance No. 2019-01 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Local Finance Committee, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section 447 (a) (1) (viii) of RA 7160;

WHEREAS, Section 3, No. 5 of the Ordinance provides that the position created is Local Disaster Risk Reduction Management Officer IV, Salary Grade 23. In the 2019 Annual Budget of the municipality, however, the position indicated in the plantilla of personnel is Assistant Department Head (LDRRMO IV), Salary Grade 22, and that said position is granted Representation and Transportation Allowance (RATA). The position title shall therefore be corrected as Municipal Government Assistant Department Head (LDRRMO IV), Salary Grade 22, to be entitled to RATA;


