APPROVING RESOLUTION NO. 07, S-2019 OF THE SANGGUNIANG BAYAN OF CALASIAO, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) OF THE MUNICIPALITY OF CALASIAO FOR THE YEAR 2019"

WHEREAS, the Sangguniang Bayan of Calasiao, Pangasinan submitted its Resolution No. 07, Series of 2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Municipal Development Council of Calasiao, Pangasinan has prepared the municipality's Supplemental Annual Investment Program for CY 2019. This was endorsed thru MDC Resolution No. 1, S-2019 dated January 29, 2019 to the Sangguniang Bayan for approval. The Sangguniang Bayan approved said endorsement through Sangguniang Bayan Resolution No. 07, S-2019 dated February 7, 2019;

WHEREAS, the Supplemental Annual Investment Program, which has a total investment requirement of P15,725,807.18 will be sourced from the General Fund (P12,000,000.00) and from the operation of Economic Enterprise (P3,725,807.18) of the LGU. Said Supplemental AIP covers augmentation funds for Personal Services (increase in salaries of employees, etc.), MOOE and Capital Outlay of various departments of the LGU, and other development projects;
