APPROVING RESOLUTION NO. 24-02172020 OF THE SANGGUNANG BAYAN OF POZORRUBIO, PANGASINAN, ENTITLED "APPROVING THE ANNUAL INVESTMENT PROGRAM OF THE MUNICIPALITY OF POZORRUBIO, PANGASINAN FOR CY 2020 FUNDED BY THE GENERAL FUND, 20% DEVELOPMENT FUND, 5% CALAMITY (LDRRM) FUND OF THE LGU AND EXTERNAL SOURCE (NGAs) FOR ASSISTANCE TO THE MUNICIPALITIES PROGRAM"

WHEREAS, the Sangguniang Bayan of Pozorrubio, Pangasinan submitted its Resolution No. 24-021722020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Pozorrubio, Pangasinan has formulated the municipality's Annual Investment Program for Calendar Year 2020 and endorsed thru MDC Resolution No. 02, S-2019 dated October 14, 2019 to the Sangguniang Bayan for approval. This was approved by their Sangguniang Bayan through Resolution No. 24-02172020 dated February 17, 2020. This is in pursuance to Sections 106, 109 and 114 of RA 7160;

WHEREAS, the Annual Investment Program of the municipality is in accordance with the Budget Operations Manual (BOM) for Local Government Units, 2016 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular (JMC) No. 1, S-2007 dated March 8, 2007 and DBM-CCC-DILG JMC No. 2014-1 dated August 7, 2014 as amended by DBM-CCC-DILG JMC No. 2015-1 dated July 23, 2015 as to format and content. The AIP of Pozorrubio, Pangasinan was formulated following the prescribed

AIP Summary Form categorized into general public, social, economic and other service sectors and covers: a) all the regular budgetary items for the operation of the different municipal offices broken down into: Personal Services (PS), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay, b) the priority development programs/projects of the LGU including those to be funded by the 20% development fund, and c) Disaster Risk Reduction (DRR) Management Programs/Projects/Activities of the municipality. It also includes the following: a) Gender and Development Plan, Local Climate Change Action Plan, Peace and Order Plan, Annual Cultural Development Plan, Municipal Nutrition Action Plan and 2) list of programs/ projects/activities for Senior Citizens and Persons with Disabilities and Local Council for the Protection of Children, and to address the problem on illegal drugs and to combat Aids;

WHEREAS, the AIP of Pozorrubio, Pangasinan has a total investment requirement amounting to P252,307,515.42. Of this, P233,327,515.42 will be funded by the municipality's 2020 Annual Budget which was enacted by the Sangguniang Bayan through Appropriation Ordinance No. 01-02172020 dated February 17, 2020 while the remaining amount of P18,980,000.00 will be funded by National Government Agencies under Assistance to Municipalities Program;

WHEREAS, the development fund amounting to P38,100,000.00 which is allocated for development projects is twenty percent (20%) of the LGU's IRA (P190,054,508.00) for CY 2020. This is in accordance with Section 287 of RA 7160;

WHEREAS, the identified development programs/projects to be funded by the 20% of IRA were based on the DILG-DBM Joint Memorandum Circular No. 2017-1, dated February 22, 2017 entitled "Updated Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment (IRA) for Development Projects";

WHEREAS, the programs/projects/activities identified to be funded by the 5% Local Disaster Risk Reduction and Management Fund of the municipality amounting to P12,000,000.00 conforms with Section 21 of RA 10121 and NDRMMC, DBM & DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 (Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund). However, the LDRRMF Plan of the municipality shall be submitted to the Office of Civil Defense (OCD) for review as provided Item 2.2.12 of the Department of Budget and Management-Local Budget Memorandum No. 77 dated May 15, 2018 ;

WHEREAS, the LGU has also identified programs, projects and activities responsive to Climate Change and tagged its corresponding expenditures in their AIP. This is in pursuance to DBM-CCC-DILG Joint Memorandum Circular No. 2015-01 dated July 23, 2015;


