## **RESOLUTION NO. 349-2022**

DECLARING MUNICIPAL ORDINANCE NO. 124, S-2022 OF THE SANGGUNIANG BAYAN OF SAN NICOLAS, PANGASINAN, ENTITLED "AN ORDINANCE REGULATING THE MOBILITY OF INDIVIDUALS UNVACCINATED FOR COVID-19 IN THE MUNICIPALITY OF SAN NICOLAS, PANGASINAN AND PROVIDING PENALTIES FOR VIOLATION THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

**WHEREAS**, the Sangguniang Bayan of San Nicolas, Pangasinan submitted its Municipal Ordinance No. 124, S-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section 447 (a) (1) (iii) (5) (xii) R. A. No. 7160 and Executive Order No. 0011-2022, implementing the COVID-19 protocols to be observed within the province;

**WHEREAS**, subject ordinance shall take effect after compliance with the requirements of posting and publication pursuant to Sections 59 (c) and 511 (a) of R.A. No. 7160;
