PROVINCIAL RESOLUTION NO. 351-2021

ENJOINING ALL LOCAL GOVERNMENT UNITS IN THE PROVINCE OF PANGASINAN TO USE THE RT-PCR TEST PROCEDURE PARTICULARLY NASOPHARYNGEAL AND OROPHARYNGEAL SWABS IN TESTING SUSPECTED PATIENTS OF COVID-19

WHEREAS, many diagnostic tests for COVID-19 are now available and one of them is the Reverse Transcription Polymerase Chain Reaction (RT-PCR) test;

WHEREAS, the RT-PCR is considered the current standard test for detecting the presence of the COVID-19 virus and it has higher sensitivity and specificity abilities;

WHEREAS, the RT-PCR test is also capable of producing results in a shorter period of time and one of the essential methods of detecting the infectious virus is through the oropharyngeal and nasopharyngeal swabs;

WHEREAS, the oropharyngeal and nasopharyngeal swabs appear to be the best way to collect sample/specimen for testing suspected patients of COVID-19;

WHEREAS, diagnostic testing is an important element to guide COVID-19 management, and detection of the presence of infectious virus by oropharyngeal and nasopharyngeal swabs are considered accurate;

WHEREAS, it is the aim of the Sangguniang Panlalawigan to follow the gold standard in determining suspected patients of COVID-19 in the Province of Pangasinan;
