DECLARING ORDINANCE NO. 11-2021 OF THE SANGGUNIANG BAYAN OF SAN JACINTO, PANGASINAN, ENTITLED "AN ORDINANCE CREATING THE POSITION OF ONE (1) ADMINISTRATIVE AIDE I (UTILITY WORKER I) (SG-1) AND APPROPRIATING FUNDS THEREOF UNDER THE HUMAN RESOURCE MANAGEMENT AND DEVELOPMENT OFFICE OF SAN JACINTO, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT
