**PROVINCIAL RESOLUTION NO. 355-2020**

**URGING ALL LOCAL GOVERNMENT UNITS AND OTHER CONCERNED AGENCIES IN THE PROVINCE OF PANGASINAN TO FULLY OBSERVE AND STRICTLY IMPLEMENT LAWS AND POLICIES PRESCRIBED TOWARDS THE PREVENTION, REDUCTION AND MITIGATION OF COVID-19 CASES**

**WHEREAS**, it is the declared policy of the State to promote the ideals of good governance in all its branches, departments, agencies, subdivisions and instrumentalities including government-owned and/or controlled corporations and local government units;

**WHEREAS**, the national government has been taking exceptional measures to slow down the spread of COVID-19 in the country;

**WHEREAS**, essential laws and policies such as RA 9271, otherwise known as the Quarantine Act of 2004; RA 11332, otherwise known as the Mandatory Reporting of Notifiable Diseases and Health Events of Public Health Concern Act; RA 7581 or the Price Act; and Department of Trade and Industry Memo-Circular No. 20-07 on Anti-Hoarding and Anti-Panic Buying and other equally important measures are to be fully observed and strictly implemented during this current public health crisis;

**WHEREAS**, likewise, the Provincial Government of Pangasinan, through the Sangguniang Panlalawigan has passed relevant local ordinances on COVID-19 like Provincial Ordinance No. 12-2020 known as the “Mandatory Wearing of Face Mask”, and Provincial Ordinance No. 13-2020 known as the “Anti-Covid-19 Discrimination Ordinance of 2020”;

**WHEREAS**, local government units and other concerned agencies play crucial roles in addressing and managing this crisis brought about by COVID-19 and they have been day by day facing unprecedented challenges amid the outbreak;



**NOW, THEREFORE**, on motion of SP Member Margielou Orange D. Humilde-Verzosa, duly seconded, it was –


