**PROVINCIAL RESOLUTION NO. 356-2020**

**STRONGLY URGING ALL LOCAL CHIEF EXECUTIVES THROUGH THEIR MUNICIPAL SOCIAL WELFARE AND DEVELOPMENT OFFICERS, AND BARANGAY CAPTAINS IN THE PROVINCE OF PANGASINAN TO CAUSE THE POSTING IN CONSPICUOUS PLACES THE MASTERLIST OF QUALIFIED BENEFICIARIES OF THE SOCIAL AMELIORATION PROGRAM**

**WHEREAS**, the Social Amelioration Program (SAP) is intended to provide financial assistance to the most affected residents of every locality in the country under community quarantine;

**WHEREAS**, under the Program, a special subsidy involving cash amounting to P5,000.00 to a maximum of P8,000.00 shall be provided for the basic needs of poor families;

**WHEREAS**, the Department of the Interior and Local Government (DILG) has directed all local government units to fast-track the distribution of the Social Amelioration Card (SAC) and come up with a masterlist of qualified beneficiaries;

**WHEREAS**, it is important that the list of qualified beneficiaries of the SAP be fully disclosed to the public by posting it to prominent public places like the barangay hall;

**WHEREAS**, local government units through their respective Municipal Social Welfare and Development Officers and the barangay captains will play important roles in the promotion of an honest, transparent and orderly management of the SAP in the Province of Pangasinan;


