RESOLUTION NO. 357-2019

DECLARING MUNICIPAL ORDINANCE NO. 2, S-2018 OF THE SANGGUNIANG BAYAN OF BAUTISTA, PANGASINAN, ENTITLED "AN ORDINANCE CREATING THE LAND MANAGEMENT COUNCIL AND LAND MANAGEMENT OFFICE IN THE MUNICIPALITY OF BAUTISTA, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Bautista, Pangasinan submitted its Municipal Ordinance No. 2, Series of 2018 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 443 and 447 (a) (1) (viii) of RA 7160; RA 10023 (An Act Authorizing the Issuance of Free Patents to Residential Lands); DENR Administrative Order No. 2011-06 or Prescribing the Guidelines in the Implementation of Public Land Titling in Partnership with LGUs;

WHEREAS, however, the Sangguniang Bayan shall consider the observations of the Provincial Legal Officer stated in her opinion dated November 15, 2019, as attached in this Resolution;
