URGING ALL LOCAL GOVERNMENT UNITS TO CAUSE THE GIVING OF SECURITY OF SERVICE/TENURE TO THE BARANGAY HEALTH WORKERS IN THE PROVINCE OF PANGASINAN

WHEREAS, Barangay Health Workers are indispensable partners of the local government units in the promotion of basic health programs, projects and activities particularly in the barangays;

WHEREAS, at present, there are more or less than 14,000 barangay health workers in the Province of Pangasinan;

WHEREAS, during this period of pandemic, barangay health workers are also in the frontline service helping to contain the spread of Covid-19 virus;

WHEREAS, there are times when barangay health workers are being replaced or terminated without due course because they have no security of service;

WHEREAS, Resolution No. 02, Series of 2021 of the Federated Barangay Health Workers Province of Pangasinan, Inc., dated March 27, 2021, has requested the Sangguniang Panlalawigan, through the Chairman of the Committee on Health, for the passage of a resolution giving a security of service to the Barangay Health Workers in the Province of Pangasinan;

WHEREAS, the Sangguniang Panlalawigan fully supports the intent and purpose of the said resolution of the Federated Barangay Health Workers Province of Pangasinan, Inc.;
