DECLARING MUNICIPAL ORDINANCE NO. 01, S-2018 OF THE SANGGUNIANG BAYAN OF STO. TOMAS. PANGASINAN, ENTITLED "AN **ORDINANCE** ESTABLISHING THE MUNICIPAL BIRTHING CLINIC OF STO. TOMAS, PANGASINAN, APPROPRIATING FUNDS THEREOF AND **DEFINING ITS ADMINISTRATION** PURPOSE AND **OPERATION**" AS WITHIN CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Sto. Tomas, Pangasinan submitted its Municipal Ordinance No. 01, Series of 2018 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 447 (a) (1); 17 (a) (b) (2) (iii) of RA 7160;

WHEREAS, however, the Sangguniang Bayan shall consider the observation of the Provincial Legal Officer on the funding requirement stated in her opinion dated September 5, 2018, as attached in this Resolution;
