**DECLARING CITY ORDINANCE NO. 22, S-2016-19 OF THE SANGGUNIANG PANLUNGSOD OF URDANETA, PANGASINAN, ENTITLED "AN ORDINANCE APPROVING THE SCHEDULE OF MARKET VALUES OF ALL REAL PROPERTY INCLUDING OTHER STRUCTURES AND AGRICULTURAL LANDS AS THE BASIS IN THE GENERAL REVISION OF REAL PROPERTY ASSESSMENTS IN THE CITY OF URDANETA IN ACCORDANCE WITH THE LOCAL GOVERNMENT CODE OF 1991 AND TO TAKE EFFECT BEGINNING CALENDAR YEAR 2019" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG PANLUNGSOD TO ENACT**

**WHEREAS**, the Sangguniang Panlungsod of Urdaneta, Pangasinan submitted its City Ordinance No. 22, S-2016-19 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer and the Provincial Treasurer, have conducted initial review and study on said city ordinance and found out that the same was enacted pursuant to Sections 218, 219, 221, 223, 458 (2) of RA 7160;

**WHEREAS**, subject ordinance shall take effect after all the legal requirements of public hearing, posting and publication pursuant to RA 7160 are complied with;
