RESOLUTION NO. 364-2019

DECLARING MUNICIPAL ORDINANCE NO. 2018-03 OF THE SANGGUNIANG BAYAN OF **BALUNGAO.** PANGASINAN, ENTITLED "AN ORDINANCE DECLARING AS UNLAWFUL ACT THE USE OF MODIFIED MUFFLERS CAUSING NOISE POLLUTION AND PUBLIC DISTURBANCE, AND FURTHER IMPOSING PENALTIES FOR **VIOLATIONS THEREOF"** AS WITHIN THE **CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT**

WHEREAS, the Sangguniang Bayan of Balungao, Pangasinan submitted its Municipal Ordinance No. 2018-03 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 447 (a) (1) (iii), (2) (vi), (5) (v) of RA 7160; and Article IV (Accessories of Motor Vehicles); Section 34 of RA 4136 (An Act to Compile the Laws Relative to the Land Transportation and Traffic Rules, to Create a Land Transportation Commission and For Other Purposes);

WHEREAS, however, the Sangguniang Bayan shall consider the observations of the Provincial Legal Officer stated in her opinion dated March 7, 2019, as attached in this Resolution;

WHEREAS, subject ordinance shall take effect after the Sangguniang Bayan has complied with all the legal requirements pursuant to RA 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Salvador S. Perez, Jr. and Noel C. Bince and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Arth Bryan C. Celeste, duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 2018-03 of the Sangguniang Bayan of **Balungao**, Pangasinan, entitled "An Ordinance declaring as unlawful act the use of modified mufflers causing noise pollution and public disturbance, and further imposing penalties for violations thereof" as within the conferred powers of the Sangguniang Bayan to enact;
